About CATIS

 The CATIS logo is an outline of a person sitting at a desk and on the desk is a computer and smart phone with a cane leaning against the desk. ACVREP

- The Academy for Certification of Vision Rehabilitation & Education Professionals (ACVREP) has created the CATIS certification.
- Other professional certifications through ACVREP include:
 - Certified Low Vision Therapist (CLVT)
 - Certified Orientation and Mobility Specialist (COMS)
 - Certified Vision Rehabilitation Therapist (CVRT)
 - Certified Deafblind Intervenor Specialist (CDBIS)

CATIS: What is their role?

 "CATIS are committed to excellence in serving individuals who are visually impaired to facilitate independence, communication and successful outcomes for educational pursuits, avocational interests and gainful employment."

Areas of Expertise

- CATIS must have knowledge in working with individuals who are visually impaired including:
 - Assessment
 - Instruction
 - Configuration
 - Exploration

Benefits of CATIS certification

- National standard to meet the specialized needs of individuals with visual impairments in the area of AT instruction.
 - <u>CATIS History</u>
- CATIS are Bound by a Strong Code of Ethics
 - <u>CATIS Code of Ethics</u>
- Recertification every 2 years to ensure that they remain current in the field

CATIS: Why Should Employers Require It?

- When an Employer hires a CATIS they know that they are hiring a professional that:
 - Represents best practices based on a national standard in providing Assistive Technology assessment and instruction for people with visual impairments.
 - Through their knowledge and skill will achieve the best possible outcomes for the clients that the agency serves.

A CATIS may enter the field:

- As a vision specialist
- As a technology or rehabilitation professional
- From non-related fields

Category 1 A Eligibility (ACVREP)

- A university program awarding a Bachelor's or Master's degree in vision studies with emphasis in Assistive Technology or a Certificate program in vision studies with a specialization in Assistive Technology
- 350 hour Assistive Technology internship through a university approved program.
- University options

Category 1 B Eligibility (ACVREP)

- 1. Education Requirements (any of the following)
 - a) University/college bachelors in any field combined with a graduate degree in vision studies (or equivalent foreign degree or diploma as verified by a NACES organization)
 - b) A licensed or certified TVI
 - c) Certification in COMS, CVRT or CLVT
- 2. University Certificate Program in Assistive Technology for the Blind/Visually Impaired
- 3. 350 hour internship

Category 2 Eligibility

- Is based on a matrix of:
 - Formal education
 - Assistive technology education in the field of vision impairment
 - General technology education
 - Required hours of direct service experience in the field
- <u>CATIS Eligibility Information for Category 1 and</u> <u>Category 2, including Educational and Work</u> <u>Experience Matrix for Category 2</u>

Category 2 Additional Eligibility Requirements

- Core Domain Checklist: Identifying the vision studies course work completed in the area of Assessment and Instruction.
 - UMass Boston offer an extended, Full Graduate Certificate to meet this requirement.
- 350 hour internship
 - Must be supervised by a CATIS

Other Programs and Workshops for CATIS Certification Eligibility Preparation

- Technical Education and Training (New Category 3 CATIS Eligibility Preparation)
 - World Services for the Blind
- Workshops are available through NIU and NCCU for those pursuing eligibility under Category 2 and meet all other requirements.

Assistive Technology Programs at the University of Massachusetts Boston (UMass Boston)

 - For those who qualify under category 1B
- Extended (Full) Graduate Certificate (8 courses)

AT Extended (Full) Graduate Certificate (UMass Boston)

- For those who would qualify under category 2, but need the core courses in the field of vision studies in order to qualify.
- In addition to the 5 courses in the Graduate Certificate, the following 3 courses are required for this program:
 - Braille I (3 credits)
 - Eye Anatomy and Disease (3 credits)
 - Clinical & Functional Assessment of Vision (3 credits)

Assistive Technology (Vision Studies) Master's Degree (UMass Boston)

- Master's Degree (11 courses and 37 credits)
- Includes all courses from the Extended (Full) Graduate Certificate
- Also includes the following courses:
 - Physical & Functional Aspects of VI (3 Credits)
 - Education of Students with Visual Impairments (3 credits)
 - Psychosocial Aspects of Visual Impairment (3 credits)


NCCU and NIU CATIS Core Domain Workshops

Assistive Technology Core Domain Service Delivery Flowchart

Iterative nature of the AT process

- Core domains are interrelated
- Often during the process, it may be necessary to revisit any of the core domains
- Knowledge of accessibility and digital accessibility must be intertwined throughout the process.




AT Core Domain Service Delivery Flowchart: The 4 Core Domains

Each domain is discussed in the CATIS Body of Knowledge and Scope of Practice.

This includes information about what a CATIS need to know about these core domains and do with them in practice.

- Exploration
- Assessment
- Configuration
- Instruction
